VI. Old Business

- A. **C-3 Non-Profit Status Update-** Dave Sharer informed us that we are waiting on the results of the submission of the application.
- B. Successful PBGF Derby Championship Trial at Shamokin Beagle Club- Josh Rissinger thanked Shamokin Beagle Club for hosting the trial. The days were hot, but the rabbits came easy and made for a great trial.
- C. **Show Option for PBGF Qualifier Trial-** The show can still be had at the option of the club. A show will remain a requirement for the PBGF All-Age & Derby Championship Trials and Plan A Trials for new clubs.
- **D. Youth Day Recap-** The Youth Day was a great success. There was a total of 61 kids participating. Mark Malloy asked that delegates take the topic back to their clubs to collaborate on new ideas for next year (activities, sponsorships, etc.).

- c. Enchanted Mountain- No longer joining the PBGF

VII. New Business

- Adam Keith Case- Josh Rissinger brought the member clubs up to date on the current situation involving Adam Keith.
 - NEBGF- Suspended Adam Keith for Life
 - Per AKC/Mel Stewart- Until determination is made by the AKC Panel, he is ok to run at any AKC event. The original AKC statement was the individual club had the option, but has now changed to current decision.
 - Lycoming made a motion to move forward and let the AKC continue their investigation, Sharpsville second the motion- Approved.
- Open Floor Discussion on Running Rules- Jeremy Bowles will send out our discussion and any updates in the Running Rules to vote at the January Meeting.
 - Remove Spay/Neuter restrictions from the Running Rules per AKC now allowing spayed and neutered dogs to compete in field trials.
 - Per capita rate- Keep @ \$2 per dog- leave up to the Board of Directors to decide on pay-out to the host club, in an effort to make it worthwhile financially for clubs.

- Remove East/West Championship trial rotation requirement in Running Rules-Open to any club.
- Move Derby Championship Trial off of Father's Day weekend- possibility of running in September. Other possibilities include having in conjunction with a Club's licensed trial.
- Trial Schedules- Clubs need to continue to work together (clubs close in proximity alternate classes, etc).
- 2019 AKC Nationals Judge Selection- Delegates submitted their selection and votes will be counted.

Hounds and Hunting Hall of Fame

- Stan Hepler led votes for houndsmen. Nominations included- Donald Dobbs, Dave Sharer, Edgar Burdette
- Burdette's Little Darbin led votes for hounds. Nominations included- Flat Creek BustN Loose Bandit, Main Man Tucker
- Please note: Due to the transfer of ownership at Hounds and Hunting and a misunderstanding these selections will not be in Hall of Fame consideration for this year.
- Host Club Nomination for 2019 PBGF Derby Championship Trial- Central Beagle Club
- Host Club Nomination for 2019 PBGF All-Age Championship Trial- Bald Eagle and Blue
 Juniata both were nominated for selection. Bald Eagle received the most votes, however
 after further discussion with Bald Eagle, Blue Juniata will be holding the 2019 All-Age
 Championship Trial.
